- d) reporting procedures and timelines

The question that was being asked of EdCo was not very clear. Some confusion as to what the task force was really asking. The following points were noted:

Can a template be provided?



There should be diversity in the membership.

Value in consistency.

There should be those with expertise on the membership.

Do we supply guiding principles, or should the EdCo Bylaws be more prescriptive?

Standing Committees are requesting concise guidance form EdCo. The Standing Committees are advisors to EdCo, so they need a framework which a template can apply to. EdCo needs to establish the values, the core tenants, i.e. diversity. Who really needs to be on these committees? Membership: looking for expertise and duration of term. Should the members have limited terms, so that there is more turn-over and opportunity for others to serve in these important roles?

These points will be taken back to both the Bylaw task force and the Systems Review task force. The council was also asked if there are any other thoughts to this topic to send their thoughts or ideas to Sarah, Darcy, or Natasha.

# **Discussion:**

This is a new program. It is a 2-year diploma program and there is a high demand of this type of program. All the answers may not be available at this time, but this program policy needs to be approved so that the team can continue with the next steps. This program is based on the 8-month certificate program but with higher outcomes and higher program admission requirements.

#### Discussion:

This program is a combination of the Health Care Assistant and Community Support Worker certificate programs. It was noted that Part 1, Section b) ii should be clearer, especially the link.



The 3 years of English instruction was discussed. If the admission requirement is grade 12, why will education be considered starting at grade 8? The ministry standard is Grade 10 English, but the college chose to have the admission requirement at the grade 12 level for this program. Students would not need to be in consecutive grades to qualify for the English requirement so could have some starting at the grade 8 level.

Section III, part B was mentioned. Have International students ever asked about the Indigenous specific racism? It was noted that they have not asked about this, but that Indigenous specific racism is embedded into the curriculum.

The Nursing program has been going through a program refresh. Through this refresh some courses needed to be updated. All the changes made to the courses are consistent at all partner institutions. The following points were noted for individual courses:

NURS 112 – remove the repetitive language in the description.



NURS 116 – it was noted that the number of credits seemed high as the hours were divided between lecture and lab hours. It was explained that the lab hours were instructor led. These are not typical lab hours.

NURS 117 – review the transfer section, both boxes should show 'yes'.

NURS 122 – remove the brackets at the end of some of the learning outcomes.

These were only added during the review of the learning outcomes to ensure that all parts of the curriculum were captured.

NURS 126 – the description needs a bit of editing to make it flow better.

NURS 129 – the prerequisite needs the first-aid course updated.

NURS 130 – the prerequisite needs the first-aid course updated.
